YOUR INVESTMENT for Rolls Royce Wedding Car/s and Chauffeur/s

Classic Limousine Company cars are charged from the time they arrive on site until the end of assignment as noted on the invoice/itinerary. The hire fee includes a Licensed P-Endorsed Chauffeur and a variety of car decorations and bonnet ribbons. Classic Limousine Company Chauffeurs are dressed in black suits, white shirts, gold tie and chauffeur hats.

During times of predicted heavy traffic we allow extra time namely 'traffic inclement'. There is no refund claimable should the actual hire period fall short of the agreed paid hire period.

Classic Limousine Company requests that your investment for wedding car and chauffeur is paid in full within 7 days of accepting our quote to secure your booking. We do not offer part payment plans or deposit options.

Classic Limousine Company minimum car hire is 2 hours at the stated rate.

Classic Limousine Company reserves the right to add \$100 fuel surcharge for our chauffeur services outside of Auckland Metropolitan area.

Classic Limousine Company reserves the right to charge for unexpected overtime in 30-minute increments at the stated \$300 per hour for additional service. This amount can be paid immediately by internet phone banking however we can accept cash on the day.

COVIDE RESURGENCE / EXTREME CIRCUMSTANCE

In the event of Covid resurgence Classic Limousine Company reserves the right to offer a postponement for services within 12 months period from the date of hire. In the event of extreme unforeseeable circumstances Classic Limousine Company with offer postponement if possible, or enter into discussion to provide an amicable solution for both parties.

PASSENGER ETIQUITE

Classic Limousine Company cars are smoke free at all times. The consumption of alcohol or other liquids is not permitted inside the cars. Child passengers must be accompanied by an adult and supervised at all times.

Classic Limousine Company accepts no liability for any personal items held by the passenger/s or any item left in the vehicle during or after completion of the agreed hire period.

Classic Limousine Company cars are groomed thoroughly prior to hire and we accept no liability for the unlikely event of clothing being marked or stained by road grime, oil or grease, from any part of the vehicle.

OUR RESPONSIBILITY:

We make every endeavor to ensure that our vehicles are in excellent condition both visually and mechanically through regular detailing and frequent servicing. All drivers have Passenger endorsed service licenses. All vehicles have a current Warrant of Fitness and Certificate of Fitness.

Classic Limousine Company accepts no responsibility for delays caused by but not limited to traffic delays, breakdown, incorrect information, acts of nature or any situation beyond our control.

CANCELLATION OF HIRE:

1/ Any cancellation requested more than 91 days prior to the hire date, 100% of the booking rate will be refunded, less any costs (if any) incurred by us for special request or such other requirement requested by the hirer.

2/ Any cancellation requested between 61 and 90 days prior to hire date will incur a 20% charge of the total hire rate, less any costs (if any) incurred by us for special request or such other requirement requested by the hirer.

3/ Any cancellation requested between 31 and 60 days prior to hire date will incur a 30% charge of the total hire rate, less any costs (if any) incurred by us for special request, or such other requirement requested by the hirer.

4/ Any cancellation made within 30 and 8 days of hire date will incur a 40% charge of the total hire rate, less any costs (if any) incurred by us for special request or such other requirement requested by the hirer.

5/ Any cancellation made within 7 days of hire date 0% charge of the total hire rate will be refunded. We will however honor your booking for an agreed postponement date.

In all scenarios, an administration fee of \$40 will be subtracted from the refunded amount.
